- 1. To receive apologise for absence and consider if the reason for the absence should be formally approved by the council: Councillor Graham Reddaway
- 2. To receive any Declarations of Interest from members:

  Councillors are reminded to declare any personal or prejudicial interests they may have in any agenda items: none declared
- 3. To receive the Minutes of the Previous Meeting held on Monday December 5<sup>th</sup> 2016:

  Copies of which have been previously circulated to members and are to be agreed and signed as a true record of the previous meeting held on December 6<sup>th</sup> 2017. All agreed and the minutes were signed.
- 4. Report by West Devon Borough Councillor: In the Planning Department Anna Henderson-Smith is returning and Patrick Whymer is staying as Head of Community Practice. Budget setting will be done with a £400,000 deficit to find. However it seems they have recuperated some monies and that has now fallen to £140,000. They will be discussing charging for the removal of garden waste. However this may cause more problems in the urban areas rather than the rural areas. The Clerk reported that there were problems putting information onto the web site and Lois said she would look into this. The Council also complained about the lack of information passed down from WDBC Planning over the on-going Enforcement cases. Lois said that she will chase this up as well.
- 5. Past Subject Matters for further discussion:
  - 5.1 [4.1] Noticeboard: This is not quite completed.
  - 5.2 [4.3] Dog Noise within the village: a letter had been received from the Environmental Health and this was read out. It was decided to write to Mr and Mrs Margetts enclosing a copy of the letter. They can then follow this up and decide if they wish to pursue this further.
  - 5.3 [8.6] Water on road ref: coach house: water runs down the road. The water apparently drains out of the fields of Lower Lane into a gully onto the Coach House and into the drain. Highways have been a few times to clear the gully. There is a drain by Thatch End which is now overgrown. The problem seems to stem from the lane. The clerk was asked to write to Messrs Bailey and Risdon to see if they could shed any light on the problem. The council need advice on what the cause/problem is before they can contact Highways.
  - 5.4 [8.7] Gullies and drains: Councillors Ward and Reddaway will coordinate and arrange for these to be cleared. It was agreed to engage a certified contractor to complete the job.
  - 5.5 [8.8] Road to Winkleigh ref: Broadwoodkelly: a letter was sent and they will contact Highways about this.
